This action does not release the applicant from obtaining a consistency determination pursuant to N.J.A.C. 7:8-1 et seq. (Monmouth County Areawide Water Quality Management Plan). Prior to commencing any work within the right-of-way of a county highway or before doing any work that affects a county bridge, the applicant is required to obtain a road opening permit from the Monmouth County Highway Department. A review of the location of subsurface utilities within county road rights-of-way will be conducted by the County Highway Department upon application for a road opening permit. Prior to planting or removal of trees or shrubs within or along the right-of-way of a county highway, the applicant is required to obtain a permit from the Monmouth County Shade Tree Commission.

Note: County review is made only on items covered by statutory authority.

The following items must be addressed before formal review and action by the Development Review Committee:

1. Respond to the comments in Victorino B. Zabat's memorandum dated February 24, 2020.

2. Revise site plan to provide islands to prohibit left turns into and out of the property on both the western and eastern drivewavs.

3. Clarify whether the lots will be consolidated or if a cross-access between the lots is proposed.


4. Submit a justification for two driveways at the site.

Partial County Bridge Map with site location, reduced, unsigned, un-sealed, un-dated 3.

Please request the following from the applicant and the applicant's engineer, so that we can continue our review:

- The partial County Bridge Map, Item 3 above did not delineate the drainage area to the 1. County Structure.
- The original site plan application, MRSP 9734, proposed less than one (1) acre of impervious area. The impervious area present application, MRSP 9734A, will exceed one (1) acre of 2. cumulative impervious area.

A Bridge Assessment will not be necessary at this time.

- Indicate historic, surveyed centerline of C.R. 520, Newman Springs Road. Provide survey 3. references.
- Provide dimensions from the centerline of C.R. 520, Newman Springs Road to: 4.

4.d. (continued) Above-ground and underground elements of the stormwater basin shall not encroach into the C.R. 520, Newman Springs Rd. right-of-way.
Place note on detail, Site Plan, Grading Plan and Drainage & Utility Plan, stating above requirement, and that if inspection reveals encroachment into C.R. 520, Newman Springs Rd. right-of-way, relocation shall be at contractor's expense.

Please request that the applicant and the engineer to provide an itemized response to these comments.
