Upon joining, your microphone will be muted. At the appropriate point in the meeting, you will be unmuted by the meeting host so that you may comment.

In advance of the remote public meeting, public comments can be submitted by electronic mail and in written letter form to the Planning Department, by the Monday before each meeting. For the November 18, 2020 any written comments must be submitted by 12:00pm on Monday November 16, 2020. For the December 2, 2020 meeting any written comment must be submitted by 12:00pm on Monday November 30, 2020. For the December 16, 2020 meeting any written comments must be submitted by 12:00pm on Monday December 14, 2020. Please send all written comments with your name, address, telephone number,

e-mail address, application you wish to comment on and if you would like to speak at the meeting.
