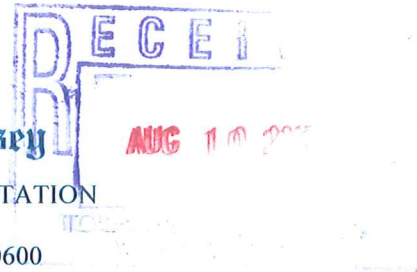

Dear Mayor Hornik:

Enclosed is one copy of the executed Agreement signature page, approved by the New Jersey Department of Transportation for the Texas Road – Phase II project which is advanced under the FY 2015 Municipal Aid Program in the total amount of \$240,000.00.

This project will be funded from the New Jersey Transportation Trust Fund Authority Act. State participation in the cost of the project is limited to 100 percent of the cost of the completed construction work including construction supervision, inspection and material testing, or the amount of the allotment, whichever is less.

The construction contract must be awarded **within 24 months** from the date of the execution of the Agreement. Failure to make an award **by July 17, 2017**, or failure to comply with the requirements of the Municipal Aid Regulations, N.J.A.C. 16:20B, and/or the Terms and Conditions of Grant Agreement for State Aid to Counties and Municipalities, will jeopardize the use of State funds on this project. It is further noted that the project must be in compliance with the Americans with Disabilities Act requirements for accessibility. Through the approval of this agreement and all future agreements, the Sponsor is required to provide phased submission updates that are to be tracked through the on-line SAGE System in accordance with the State Aid Checklist (copy attached).


Please note, that the Sponsor is responsible for continued updates with respect to the construction administration/management phase of the project in the SAGE System. The preparation of the contract documents shall use the NJDOT 2007 Standard Specification for Road & Bridge Construction, as


